At the heart of our work is our commitment to support people to live in their own homes in a way that promotes their independence and choice.

Appointments to the role are made at the entry level of the salary quoted above, however in exceptional circumstances where a candidate's experience and skills may justify a higher starting salary.

MAIN RESPONSIBILITIES:

The key responsibilities of the role are to manage a team of Support Workers to ensure that service delivery is of a high quality that meets regulatory and statutory requirements and the needs of our supported people.

The Team Leader will:

- Provide leadership to the team acting as a positive role model.
- Oversee the recruitment, selection and induction of support staff.
- Manage rotas on a daily basis to ensure a consistently high-quality service is being provided.
- Motivate, support and mentor staff to ensure good team work and provide effective supervision to your team members.
- Ensure service users receive tailored person-centred support which meets and improves their health and wellbeing needs.
- Design, co-ordinate, manage and lead the provision of existing and new care and support services with the involvement of the people we support and their families or representatives.
- Ensure safe procedures for the collection, storage and administration of medication in compliance with the organisation's policies.
- Be responsible for ensuring that staff carry out all financial transactions involving supported people to company policy and procedures.
